3. Work shall NOT commence until application is approved.
4. Approved applications shall NOT be altered.
5. Contractors employed must provide Certificate of Liability Insurance/Workers' Compensation when required by law.
6. Owner is responsible for making sure all required permits are obtained prior to start of any work.

Special Guidelines for Window/Sliding Door Replacement

1. All replacement windows/doors must meet local code requirements.
2. Image(s), size(s) and description(s) of proposed windows/doors must be included.
3. White, impact resistant, double or single hung windows
4. White Colonial grids (mullions) between glass or on inside of window. 8 panes on upper window, 8 panes on lower window. NOTATION of such must be provided.
5. NO grids (mullions) on sliding doors
6. Reflective Low E glass is NOT permitted. NOTATION of such must be provided.
7. Copy of current certificate of liability insurance must be provided.
8. Architectural Review Form must be submitted to Sunstate.

ALL WINDOWS/DOORS MUST BE REPLACED LIKE FOR LIKE - NO MODIFICATION TO DESIGN APPEARANCE.

Special Guidelines for Flooring Replacement

For proper sound abatement underlayment must have a STC rating of 55 or above and must be professionally installed.
