5) Treasurer's Report

Pete Tyree stated as of October 31 Perico Bay Village had \$621,190 in the bank. Year to date the association is positive \$16,466 in the operating account

6) Old Business

- A) Landscaping update- Mark Botti reminded everyone that the landscape contract with WestBay started on November 1, 2020. Also stated that the landscape has asked WestBay to start some landscape designs. Laurel Finch did walk the property with Nick at WestBay Landscape. WestBay is committing to a lifetime warranty for any plants they put in. WestBay is working on a three year landscape plan and will be meeting with the landscaping committee in the coming weeks and months to make this happen. Also waiting on the arborist from WestBay to come and look at the dead palm in front of building #7 and look for other dead trees on property.
- B) Tree Trimming- Simply Tree has completed trimming of the nine palms rubbing against the building and roofs.
- C) Painting by Artistry- Painting began on the painting on Monday November 16th, and he also discussed the importance of having ALL items removed from your landings so nothing gets damaged while the crew is power washing the buildings. Artistry is hopeful

that they will be moving on to the next building by Wednesday, December 2, 2020. All stucco repair work that needs to get done on a particular building will be done before the painting starts on that building.

7) New Business

A) Discussion & consideration for the 2021 Budget

Motion by Russ Stanley to approve the 2021 budget with the quarterly maintenance fee of \$1.815.75. Motion was seconded by Mark Botti. Approved by all. Motion carried 5-0
